Aguilar assigned the topic to the Public Services Committee for their review.

Rolwing spoke about the formation of the new country South Sudan.

Brown said State Legislators are being invited to Sioux Falls on August 18, 2011. More information will be provided at a later date.

Aguilar asked Darrin Smith, Director of Community Development to provide more information on Item 11 on this evening's agenda. Smith said the item is a Resolution to allow the city to submit an industrial park grant to help build North Bahnson Avenue Industrial Park 8.
