1. Call To Order

City Council Chair Sue Aguilar called the meeting to order at 4:00 p.m.

2. Staff Report

A. Sue Roust, Interim City Clerk

Roust reviewed a memo that she gave to the Council. She said that Fuel Bids will now be listed on the agenda and recorded in the minutes. She discussed the new wording for agreements/contracts on the agenda. She said it has been made clear that the Council is approving those items and not just receiving notice of them. Roust said there would be a walk in of two contracts at tonight's meeting.
