2. Staff Report

A. Jim David, Legislative/Operations Manager

Minnehaha County; Senate Bill 173, a water funding bill that includes a \$7.7 million advance for Lewis & Clark expansion to Madison; and Senate Bill 1, a transportation funding bill.
