RESOLUTION NO. 37-15

A RESOLUTION OF THE CITY OF SIOUX FALLS IMPLEMENTING A PROGRAM PROVIDING YOUTH AN OPPORTUNITY TO RIDE FIXED ROUTE BUS SERVICE AT NO CHARGE.

WHEREAS, a healthy public transportation system plays an important role in preserving and improving the mobility of persons participating in the social and economic life of this community; and

WHEREAS, promoting youth ridership encourages life-long habits, and appreciation for the role public transportation plays in our community; and

WHEREAS, school districts in the city of Sioux Falls dismissed students in May 2015 for summer break; and

WHEREAS, youth is defined as a person 18 years of age or younger; and

WHEREAS, City Ordinance 124.012 allows implementation of this program under Special Promotions/Marketing;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF SIOUX FALLS, SD:

That Sioux Area Metro shall implement a program that provides youth an opportunity to ride fixed route service at no charge until September 8, 2015.

That any 2015 summer youth passes (dog tags) purchased can be refunded pursuant to the terms and conditions as set forth by this program and with proof of purchase as determined by Sioux Area Metro.
