Brent O'Neil, Economic Development Manager, provided an overview of the Economic Development division; 2016 Budget overview; 2016 Use of Funds; Operating Budget Major Changes; Partnerships & Initiatives; Tax Increment Financing; and Workforce Development. Discussion followed.
