2. SIOUXLAND  
HERITAGE MUSEUM ARCHIVE BUILDING DISCUSSION.

Commissioner Jeff Barth said the County has been going through their budget and starting in 2014 plan to spend \$170,100.00 a year, for the archive facility. He said this has been an item of discussion for many years. Barth said he recognized that the City doesn't have money for the facility at this point. He said since this is a joint facility, it is time that we start discussing it more seriously. Barth suggested the creation of an ad hoc committee to look at this.

Council Member Michelle Erpenbach said that both the County and City would be storing items in the facility. She agreed with Barth and said they need to

move forward. Kelly said they wanted to know where the City is in the process. He suggested that they stay (monetarily) on track with each other. Council Member Greg Jamison said it is in the City's 2017 budget for \$475,000.00. He added that he isn't convinced that there is a space needs problem and that education is needed on this project. Discussion followed.

Kelly and Erpenbach agreed to work together to form a committee. Council Member Sue Aguilar asked about the history of this project and what kind of commitment did the City make. Bill Hoskins, Director of the Siouxland Heritage Museum, provided a history of the project. Discussion followed.
