City Council Chair Kenny Anderson Jr. called the meeting to order at 4 p.m.

- A. Meeting of Tuesday, June 9, 2015

Committee Chair Christine M. Erickson said Mike Cooper, Director of Planning and Building Services, presented an update onchanges made to a subdivision ordinance. In a few months, he will return to present another update to the committee.

City Council Member Dean Karsky encouraged people to attend the Land Use Committee Meeting. He said he was going to begin a discussion on the alcoholic beverage ordinances.

- A. Monthly Financial Report by Tracy Turbak, Director of Finance

Tracy Turbak, Finance Director, presented the May Monthly Financial Report. Items discussed included: Sioux Falls MSA Unemployment; Building Permits YTD Permit Valuations; Sales Tax Collections w/out Audits, Cumulative 12 Month Rolling Growth Rate; Entertainment Tax Collections w/out Audits,
